

Concreting Councillors' actions will mean the equivalent of two new towns (19,000 houses & 46,000 people) the size of Witney and Thame in the greenbelt around Oxford. See our website for a detailed map showing the scale of the development.

We are a non-party political campaign group *A Better Oxfordshire*. We want to see local councillors put local people first. We are asking you to use your vote to send a message to those councillors who have not been listening to us. *If your councillor was one of them*, please do not vote for them again. We want a better Oxfordshire, and a council that will: -

The three principles above should underpin the actions of any local councillor regardless of party affiliation. Sadly, **Concreting Conservative and Labour** councillors abandoned these commitments when they supported central government imposition of planning policy over local decision making.
